# National Fair Housing Alliance Report Calls for Modernizing Fair Housing Act

The National Fair Housing Alliance (NFHA) recently released "Modernizing the Fair Housing Act for the 21st Century," its 2013 Fair Housing Trends Report.

The report finds a rise in the number of housing discrimination complaints filed by individuals and families with a marked spike in harassment complaints. Harassment complaints were up 35% from last year's numbers and include complaints because of race, national origin, disability, sex, and having children in the home. Included in the report are harassment and other complaints from Louisiana, New York, Ohio, Texas, and other states.

This year's report highlights the spike in complaints by people not protected under federal fair housing law but do have protections under state and local laws. The following show the percent rise in reporting of discrimination based on protected classes that are seen in the Ohio area:

- sexual orientation up 43%
- marital status up 63%
- gender identity and expression complaints reported for the first time

A total of 28,519 complaints were investigated in 2012 by private non-profit fair housing organizations, U.S. Department of Housing and Urban Development, the U.S. Department of Justice, and state and local government agencies such as state civil rights commissions. HUD estimates that this already high number represents less than one percent of the approximately four million acts of housing discrimination each year against current populations protected by federal law.

### Service Animal Policy Update from the Department of Housing and Urban Development

The U.S. Department of Housing and Urban Development (HUD) issued a Notice reaffirming that housing providers must provide reasonable accommodations to persons with disabilities who require assistance animals on April 25, 2013. The "Notice on Service Animals and Assistance Animals for People with Disabilities in Housing and HUD-Funded Programs" discusses how the Fair Housing Act and the Americans with Disabilities Act (ADA) intersect regarding the use of service or assistance animals by persons with disabilities.


Pet restrictions cannot be used to deny or limit housing to people with disabilities who require the use of an assistance animal because of their disability. Housing providers must grant reasonable accommodations in such instances, in accordance with the law. The guidance also describes the Department of Justice's revised definition of "service animal" under the ADA, as well as housing

providers' obligations when multiple nondiscrimination laws apply.

The Americans with Disabilities Act requires equal access for people with disabilities using trained service dogs in public accommodations and government facilities. Under the Fair Housing Act, housing providers have a further obligation to accommodate people with disabilities who, because of their disability, require trained service dogs or other types of assistance animals to perform tasks, provide emotional support, or alleviate the effects of their disabilities
