



HUD Assistant Secretary for Fair Housing & Equal Opportunity to present keynote address at April Fair Housing Month Event



The Miami Valley Fair Housing Center is please to announce that Gustavo Velasquez, the Assistant Secretary for Fair Housing & Equal Opportunity for the U.S. Department of Housing & Urban Development will present the keynote address at the 2015 Fair Housing Month Event, sponsored annually by Miami Valley Fair Housing and the Dayton Area Board of REALTORS®.

This year's event will focus on the theme of *Fostering Inclusive Communities Strengthens the Housing Market*, and will be held on Thursday, April 2, 2015 at Sinclair Conference Center. The event includes educational workshops that are approved for continuing education for Realtors and other housing professionals, followed by a luncheon, keynote presentation and presentation of the Marie Kindrick Fair Housing Awards.

Fair Housing Month Keynote Speaker

Gustavo Velasquez was nominated by President Obama and confirmed by the United States Senate to become Assistant Secretary for Fair Housing and Equal Opportunity at the U.S. Department of Housing and Urban Development. Prior to his nomination, Velasquez was Executive Director of the Latino Economic Development Center (LEDC), a non-for-profit organization based in Washington, DC dedicated to serve thousands of Latinos and other immigrants and underserved populations to gain the necessary skills and capital to start and maintain their own businesses. Prior to his tenure at LEDC, he served for seven (7) years as Director of the District of Columbia Office of Human Rights, where he led the enforcement provisions of the DC Human Right Act, considered one of the most comprehensive non-discrimination laws in the country.

Fair Housing Month Workshops

REO Management and Fair Housing Workshop

This workshop explores the impact of REO properties and abandoned foreclosures, and will highlight efforts to stabilize area communities of color. The workshop features a panel of experts who will explain what their agencies are doing to combat problems with REO properties and abandoned foreclosures. They will also talk about innovative programs to stabilize and promote growth in neighborhoods that suffered in the great recession of 2008.

The panel will include Veronica Bedell-Nevels, President of the Dayton Realtists, Karl Keith, Montgomery County Auditor, as well as other national speakers.

This course is approved for civil rights or elective continuing education credit by the Ohio Department of Commerce, Division of Real Estate and Professional Licensing.

Accessible Housing Initiatives Workshop

Fair Housing Issues for seniors and People with Disabilities are inevitable in the future of city planning. This workshop will be a discussion about the need for affordable, accessible housing as the baby boomers age and as our technology helps more people with disabilities live in the community rather that institutions. The workshop explains the problems that people with disabilities and seniors encounter in buying, owning and renting housing. Getting inadvertently "stuck" in an institution due to a long term disability is a current barrier to open and fair housing for many seniors. People of all ages need accessible features in a home so that their home is a more sustainable housing choice.

Tell us what you think about Housing Discrimination







Montgomery County, the city of Dayton and the city of Kettering are committed to eliminating racial and ethnic segregation, illegal physical and other barriers to persons with disabilities and other discriminatory practices in housing. The U.S. Department of Housing and Urban Development (HUD) provides federal funding to all three jurisdictions for their housing and community development programs. As a prerequisite to receiving these federal funds, entitlement communities, including Montgomery County, Dayton and Kettering, must affirmatively further fair housing. To accomplish this task, these communities prepare an Analysis of Impediments (AI) to fair housing, a plan to address these impediments, and then maintain records of their fair housing activities.

The Miami Valley Fair Housing Center has been contracted to facilitate the planning process. Among the many required tasks is citizen participation. To accomplish meaningful citizen participation, the Miami Valley Fair Housing Center is conducting an online survey as well as focus groups, interviews and Town Halls about obstacles to housing choice and housing opportunity/availability.

Congressman John Lewis, an American icon and one of the key figures of the civil rights movement, continues his award-winning graphic

novel trilogy with co-writer Andrew Aydin and artist Nate Powell, inspired by a 1950s comic book that helped prepare his own generation to join the struggle. Now, *March* brings the lessons of history to vivid life for a new generation, urgently relevant for today's world. After the success of the Nashville sit-in campaign, John Lewis is more committed than ever to changing the world through nonviolence - but as he and his fellow Freedom Riders board a bus into the vicious heart of the deep south, they will be tested like never before. Faced with beatings, police brutality, imprisonment, arson, and even murder, the movement's young activists place their lives on the line while internal conflicts threaten to tear them apart.
